

**Provincial Team Selection Policy For
Positions that Were Not Filled at the Provincial Championships**

Purpose:

Boxing Ontario is committed to providing a clear and transparent process for the selection of athletes for its Elite Open Provincial Team. This policy will outline how additional athletes will be selected for positions on the Provincial Team that were not awarded / remain vacant, following the conclusion of the Provincial Championships. This policy was created to provide an additional developmental pathway for Boxing Ontario athletes.

This policy will seek to fill the following positions:

WEIGHT CATEGORIES

Male 51 kg (2 spots)
Male 54 kg (1 spot)
Male 92+ kg (1 spot)
Female 48 kg (1 spot)
Female 50 kg (2 spots)
Female 52 kg (2 spots)
Female 54 kg (1 spot)
Female 57 kg (1 spot)
Female 66 kg (2 spots)
Female 70 kg (1 spot)
Female 75 kg (2 spots)
Female 81 kg (2 spots)
Female 81+ kg (2 spots)

Eligibility Criteria:

- Must be an Elite Open category athlete (born 2004 or older and 11+ bouts on your record).
- Must have a 2023 Competitive Licence.
- Must be a Canadian Citizen or Permanent Resident.
- Must be available to attend at least 1 training camp to be held in January 2023 on a weekend with Provincial team.
- Must be available to compete February 2-5, 2023, in Brampton, Ontario.
- Must have completed the submission form fully AND included a copy of his/her record book, (front and back) for review.

Athlete Selection Committee:

The High-Performance Committee will select an advisory Ad Hoc Selection Committee. The committee shall be comprised of 3-5 members and may include persons outside of the High- Performance Committee. All athlete selections shall be approved by the Boxing Ontario Board of Directors.

Selection Criteria:

Athletes will be selected based on an assessment of their performance as outlined in their Boxing Ontario Record Book (Passport).

The Committee will use a weighted point system for the following Sections:

1. Overall win/loss Record.
 - This section's score will be weighted at 50 percent of the entire score.
2. Win/loss Record over the past 24 months.
 - This section's score will be weighted at 50 percent of the entire score.
3. If two or more athletes vying for the same weight category were matched (against each other) within the previous 24 months, the results of their contest(s) will be taken into consideration.
4. If two or more athletes vying for the same weight category were matched with the same opponents within the previous 24 months, the results of their contest(s) will be taken into consideration.
5. The committee reserves the right to use discretion for athlete selection based on points 3 and 4 as outlined above. If discretion is used, and the selection is not based solely on the weighted point system, an explanation of the selection will be provided to all athletes involved.

Appeal Process:

Any athlete has the right to appeal their non-selection for the Boxing Ontario Provincial Team. Appeals can only be made on the grounds that the published selection criteria were not followed directly.
